**** It was also decided to charge only the admission charges from Ph.D. candidates at the time of admission. Other remaining charges shall be deposited at the time of registration in IInd Semester 2003-04

Agenda III- Relaxation in experience duration for SC candidates for the posts of Associate Professor and Professor.

It has been experienced, as pointed out by Chief Personal Officer and Vice Chancellor, that the SC candidates with adequate experience are not available for filling up the posts of Associate Professors and Professor reserved for SC category. The issue was discussed in detail in the meeting and it was decided to give relaxation in duration of experience required for considering the candidates for respective posts reserved for SC category in the following way.

Name of the Post	Experience Duration Prescribed at Present	Modified Duration of Experience
Associate Professor	Five years Teaching/Research/Extension (T/R/E) experience in the subject concerned at the level of Assistant Professor or equivalent	Two years (T/R/E) experience in the subject concerned at the level of Assistant Professor or equivalent.
Professor	Ten years T/R/E experience in the subject concerned out of which 5 years must be at the level of Associate professor or equivalent.	Five years T/R/E experience in the subject concerned out of which 3 years must be at Associate Professor or equivalent.
