





Agenda – 2 In view of ICAR quota seats which remained unfilled, the Registrar has put-up a proposal to increase the NRI seats for BBT (03 to 08) & B.Sc. (Ag.) (01 to 02). The proposal was accepted and passed unanimously.


Agenda – 3 Some seats like University Employee remained also unfilled in the B.Sc. Ag. & BBT programmes. Registrar has also put-up a proposal to fill up these vacant seats from their respective categories as paid seats. Seat vacant in the General FF & PH category may be filled from general AF. Seat vacant in the SC (Paid) may be filled from SC (Paid) during Re-Counseling. The house agreed with the proposal and passed as such.

Agenda – 4 In some of the programme of under graduates, M.Sc. (Ag.), M.Tech. (Ag. Engg. & Food Tech.) & Ph.D. Some seats also remained unfilled due to unavailability of candidates because they could not achieve the level for passing the examination. Therefore, Registrar also proposed to reduce the level of passing marks from 30% to 20% in case of General & OBC category and 20% to 10% in case of SC category. The proposal was accepted by the members and approved unanimously.




