
6. Persons already in employment should upload No Objection Certificate (NOC) as per the format from the present Employer and send their application along with original No Objection Certificate (NOC). Without NOC their application will not be considered.
7. Age limit – There is no upper age limit for the post of Professor.

8. Reservation rule as per the State Government will be applicable. The claimant for reservation must furnish the certificate as applicable, issued by the competent authority of U.P. Govt. SC/ST/OBC/EWS/Persons with disability (PWD). The claimant for reservation of OBC and EWS are required to submitted the current year certificate as per the Performa of U.P. state Govt. 



- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co-supervisor. Supervisor and Co-supervisor, both shall get 7 marks each.
- *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.


1. The Scrutiny Committee will assess the Academic/Research Score as per Table-2 of applicants on the basis of information provided by the candidate in the application.
2. After calculating Academic/Research Score by the committee, the list will be published in the university website and objections will be invited. For raising objection, 07 days time will be provided. All objections will be received through an email ID recruitmentsvpuat2021@gmail.com. The objections received within the stipulated time will be resolved by the Scrutiny Committee and revised marks will be again published.
3. A merit list will be prepared on the basis of marks obtained in Academic/Research (Table-2) by the University.
4. From this merit list, the candidates will be shortlisted for interview in a ratio of 10 times for one post followed by 05 times for each additional post by the University.

Step-II of Selection Process : Interview (Maximum Marks 20)

The shortlisted candidates will be called for Step II of selection process i.e. interview. Final selection will be based on the marks obtained by the candidate in interview.

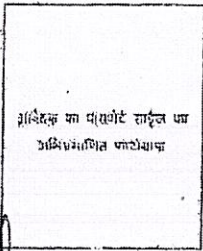
