### Notification

A statutory university named as "Sardar Vallabh Bhai Patel University of Agriculture & Technology, Meerut" has been established by Government of Uttar Pradesh By Act No. 19 of 2000 and notified by the State Government vide Notification No. 3204A-XII-8-2000-400(96)2000 dated 27-9-2000. The said university has been included in the list of universities maintained by the University Grants Commission under Section- 2 (f) of the UGC Act, 1956.

However, the above university, has not been declared fit to receive Central assistance in terms of the rules framed under Section 12- (B) of the U.G.C. Act, 1956.


