



The minutes of XXXI Academic Council meeting held on March 13, 2007 was confirmed.

Agenda – 2 For admission of employee of the University, proposal is placed for approval before the house, the proposal was approved with some modification.

Admission of Employees of University:

- (1) Subject to his fulfilling the minimum admission requirements, an employee of the University who has completed two year service including bond/probation period may, if approved by the Vice- Chancellor, be given admission to any of the degree programmes (except B.Tech) after his application submitted to the Registrar/ Coordinator (Admissions) has been recommended by the Dean/ Director/ Sectional Head under whom he is working and the Dean of the College to which admission is sought. However admission to Bachelors degree programmes shall be subject to his having qualified the Competitive Entrance Examination. Such employees will be admitted as a part-time students and shall be governed by the following conditions:
 - (a) No fees shall be charged from an employee allowed for part-time study.
 - (b) In case of post- graduate programmes, not more than 10 credits in a semester and 18 in a session, (excluding research credits) and in case of under- graduate programmes not more than 12 credits in a semester and 22 in a session shall be permitted under part-time study programme to an employee.
 - (c) The maximum period allowed to complete the various degree programme under parttime study programme shall be as follows:
 - (i) Eight semesters for master'/Ph.D. degree programme.
 - (ii) Twelve semesters for B.Sc. Ag.
- (2) The maximum number of staff candidates from University department who may be permitted by the Vice-Chancellor to undergo higher studies on the recommendations of the Head of the Department, Director and Dean of the College concerned, shall be as follows.
 - i) 20% of the total staff strength of a Department at a time for part-time study in the University. This will be covered for a block period of 2 years. Research work will be conducted preferably at his places of posting, Research station/KVK. Facilities will be provided by research station/KVK.

- ii) 10% of the total staff strength of a department at a time for full time study in the University or outside.
- iii) Minimum eligibility qualification for staff candidates sponsored by S.V.B. Patel University of Agriculture & Technology, Meerut and the candidates sponsored by the Indian Council of Agriculture Research/ Government of India / Self supporting Foreign Nationals sponsored by Government of India/ In service candidates sponsored by Indian Universities etc. shall be laid down by the Academic Council every year in advance.
- (3) Such candidates (part time) will get full salary for a period of 3 years for Ph.D. an very years for M.Sc. / M.Tech. Out campus candidates will also be covered under this clause with the condition that such candidates will be attached to the concerned department or the said period.
