
Guidelines for Forwarding Applications for Post Doctoral Fellowship (PDF) at
National and International Level


1. The applicant should be an Indian citizen.
2. The candidate must have obtained Ph.D. degree (with course work) from a recognized university.
3. He/she should have completed minimum five years of service (including clearance of probation) in regular capacity as a Teacher /Scientist in this university working in any area of Teaching/Research/Extension.
4. The upper age limit and age relaxation for the fellowship will be in accordance with the concerned Agencies / Institutes on the last date of submission of application.
5. He/ she should have atleast 03 years to retirement.
6. He/ she should have handled atleast one Research Project as PI / Co- PI in this university funded by External Agencies viz. ICAR/ DBT/ DST/State Government and other reputed organizations.
7. PDF can be availed only once by a candidate in his/her career.
8. The candidates are not allowed to work with their Ph.D. Guides or Co-guides.
9. The candidates may be allowed to avail PDF from the same University/ Institute where he / she has done M.Sc. / Ph.D. degree programme depending upon the terms and conditions of the Institute /University offering PDF .
10. Mentor must hold a regular academic/research position in concerned University/ Institute having a Ph.D. degree and should be a faculty member.
11. The mentor must have a minimum of 10 years of service experience in the relevant area of work with the experience of guiding minimum of 2 Ph. D. students.
12. The applicant shall highlight the objectives, outline of the proposed research work and its utility to the parent Institute and application shall be submitted through proper channel on prescribed proforma as per university rules.
13. Along with application, the applicants must furnish a letter of approval of research plan from the Mentor including a declaration regarding availability of adequate infrastructural facilities and equipments to execute the work plan.

14. During the programme, the awardees shall not hold any other responsibility/ post/position/work and need to devote his/her full time for the proposed research work.
15. The Post Doctoral Fellowship amount would be over and above the salary received by the awardees and the amount would be taxable as per the government of India rules.
16. In case of selection, the Post Doctoral Fellows are not eligible to receive any other fellowship from any Government or Non-Governmental sources during the tenure of the fellowship.
17. The university teacher applying for PDF may be allowed to avail study leave for one year with the condition that he / she has not availed study leave earlier for Ph.D. programme.
18. The Post Doctoral Fellow has to serve the parent university at least for three years after completion of PDF and to this effect he/she has to execute a bond compulsorily at the time of relieving as per existing university rules.
19. Period spent on PDF may be counted for promotion under CAS as per provision of UGC Guidelines / Notification dated 18th July, 2018 (clause 3.11) applicable in case of Ph.D. programme.
20. Vice-Chancellor of the University may waive the guidelines in special cases with reasons mentioned in writing and later on, ratified by the Academic Council.
